WE ARE COMMITTED TO:

- ENSURING THE CONTINUOUS IMPROVEMENT OF OUR PROCESSES, AS WELL AS ENSURING THE COMPETENCE AND SUITABILITY OF OUR STAFF, MAINTAINING AN OPTIMAL INFRASTRUCTURE AND MANAGING THE IMPROVEMENT OF WORK ENVIRONMENTS, IN ORDER TO PROVIDE QUALITY AERONAUTICAL SERVICES.
- THE ENVIRONMENT, REDUCING SIGNIFICANT ENVIRONMENTAL IMPACT FROM AERONAUTICAL ACTIVITY AND CARRYING OUT A RATIONAL MANAGEMENT OF RESOURCES.
- SECURITY AND HEALTH AT WORK, DETECTING UNSAFE ACTIONS AND CONDITIONS THAT PUT PHYSICAL AND PSYCHOLOGICAL HEALTH AT RISK, IN ORDER TO MINIMIZE RISKS AND AVOID OCCUPATIONAL ILLNESSES AND ACCIDENTS.
- INFORMATION SECURITY, REACHING ADEQUATE LEVELS OF INTEGRITY, CONFIDENTIALITY, AND AVAILABILITY OF ALL INSTITUTIONAL INFORMATION, IN ORDER TO ENSURE OPERATIONAL CONTINUITY FOR PROCESSES AND SERVICES, VIA A SYSTEM OF INFORMATION SECURITY MANAGEMENT, WHICH ENABLES THE INSTITUTION TO IDENTIFY POTENTIAL THREATS AND VULNERABILITIES THAT AFFECT INFORMATION ASSETS LINKED TO BUSINESS PROCESSES AND SUPPORT.
- AN OPERATIONAL SAFETY MANAGEMENT SYSTEM, WITH THE GOAL OF MANAGING RISKS TO OPERATIONAL SAFETY, ENSURING THAT THE NECESSARY CORRECTIVE AND PREVENTATIVE MEASURES TO MITIGATE RISKS AND HAZARDS ARE IMPLEMENTED, ACHIEVING A PERMANENT MONITORING AND REGULAR EVALUATION OF ACCEPTABLE OPERATIONAL SAFETY LEVELS.
- RISK MANAGEMENT, TO ADDRESS THE MITIGATION OF STRATEGIC AND OPERATIONAL RISK AT EACH LEVEL OF INSTITUTIONAL MANAGEMENT, SO THAT THESE RISKS DO NOT INTERFERE WITH ACHIEVING THE STRATEGIC OBJECTIVES AND THE MISSION OF THE INSTITUTION.

YOUR RIGHTS WITH THE DGAC

- RIGHT TO TIMELY AND QUALITY SERVICE.
- RIGHT TO RECEIVE A RESPONSE WITHIN A REASONABLE AMOUNT OF TIME.
- RIGHT TO OBTAIN REDRESS FROM THE GOVERNMENT.
- RIGHT TO REPORT A LACK OF ENTHUSIASTIC INVESTIGATION.
- RIGHT TO CORRECT ERRORS OR OMISSIONS.
- RIGHT TO INFORMATION FROM THE AUTHORITY.
- RIGHT TO REASONABLENESS OF ADMINISTRATIVE DECISIONS.
- RIGHT TO PETITION.
- RIGHT TO CHALLENGE POSSIBLE ABUSES OF POWER.
- RIGHT TO NON-DISCRIMINATION.
- RIGHT TO BE ACCORDED DECENT TREATMENT.

YOUR OBLIGATIONS TO THE DGAC

- PROVIDE YOUR FIRST NAME, LAST NAME, AND ADDRESS TO RECEIVE AN ADEQUATE RESPONSE.
 - MAKE YOUR REQUESTS IN RESPECTFUL AND SUITABLE TERMS.
 - MAKE CONCRETE, WELL-FOUNDED, AND CREDIBLE REQUESTS.
 - PROVIDE THE NECESSARY DOCUMENTATION FOR THE MANAGEMENT OF YOUR REQUEST OR CLAIM.
 - RESPECT THE SERVICE HOURS AND PROCESSING TIME, DEPENDING ON THE ROUTE OF ENTRY USED.
